SUMMER CAMP PARTICIPANT RELEASE AND WAIVER FORM

Liability Release. For good and valuable consideration including enabling the above mentioned Camper to attend Camp, the receipt and sufficiency of which is hereby acknowledged, I, the undersigned parent or legal guardian of the above-referenced camper, who is a minor (the "Camper"), hereby grant my permission for the Camper to participate in all Shoshana Makowsky LLC (the "Camp") activities, both on and off the Camp premises. I, on my own behalf and on behalf of the Camper, further agree to release and to hold harmless the Camp and its respective directors, officers, representatives, members, agents and employees (collectively, the "Releasees") from any and all liability and otherwise for any claim, judgment, demand, action, loss, liability, cost and expenses (including, without limitations, attorneys' fees and costs) arising out of or related to any of the Camp's activities, including without limitation any claim arising out of or related to any illness, injury or death cv's that the Camper may incur or sustain while participating in the Camp, all activities associated with the Camp including any and all field trips, and while traveling to and from the Camp location (collectively, the "Claims"). I further expressly agree to indemnify and hold harmless the Releasees and the Releasees' heirs, successors, assigns, executors and administrators against any loss from any Claims that may subsequently be brought by the Camper or by any other person in any manner related to any of the foregoing, and I further agree to reimburse and to make good to the Releasees any loss or costs that any of the Releasees may have to pay as a result of any such Claim. I hereby warrant that I have read this Release in its entirety and fully understand its contents, and I am aware that this Release is intended to release the Releasees from all liability related to any Claim and contains an acknowledgement of my voluntary and knowing assumption of all risks of the Camper attending the Camp.

Medical Release. I affirm that my child is healthy and does not have a physical or mental condition that may inhibit her from participating in all Camp activities. In case of a medical emergency, when I cannot be reached, or if Camp representatives determine in their discretion that time is of essence or that a situation warrants immediate medical attention, I hereby authorize such Camp representatives to act as my agent and to seek medical attention, obtain medical treatment and make medical decisions, in my own behalf and on behalf of the Camper, and I release and hold harmless the Releasees in exercising such authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred on behalf of the Camper for any illness or injury that the Camper may sustain during Camp activities and while traveling to and from the Camp's location. I agree that the Releasees shall not be responsible for administering any medications to the Camper or otherwise for any medications that the Camper is currently taking. I agree that I and the Camper shall alone be responsible for taking any such medications during Camp hours including for consuming the prescribed dosage for such medications.

Appearance Agreement. I understand that the Camp may from time to time produce promotional material relating to its activities. I understand that as a participant in the Camp, the Camper may be included in videotapes, photographs, and the like taken during the Camp. Therefore, without reservation or limitations, I, on my own behalf and on behalf of the Camper, hereby assign, transfer and grant to the Camp, its successors, assignees, and licensees the right to photograph and / or videotape the Camper and to utilize such videotapes and photographs and the Camper's name, face, likeness, voice and appearance in advertising and promoting the Camp any related events.

Camp Rules. I further acknowledge and understand that the Camp has established rules and regulations pertaining to conduct, behavior and activities of all Camp participants, by which I and the Camper agree to abide by, and that I and the Camper will be responsible for any failure of the Camper to abide by those rules and regulations. I and the Camper have received, read and understand the Camp rules.

I, in my own behalf and on behalf of the Camper, hereby warrant that I have read this Release in its entirety and fully understand its contents. I, in my own behalf and on behalf of the Camper, am aware that this Release releases the Releasees from all liability and contains an acknowledgement of my voluntary and knowing assumption of the risks involved in the Camper's participation in the Camp. I, on my own behalf and on behalf of the Camper, have signed this document voluntarily and of my own free will.
